All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, on the westerly side of Lake Cunningham Road, being shown and designated as Lot No. 4, on plat of W. E. Caldwell Property, recorded in the RMC Office for Greenville County, S. C., in Plat Book "7 X", at Page 62.

The within conveyance is subject to restrictions, utility easements, rights of way, zoning regulations, and other matters as may appear of record, on the recorded plats, or on the premises.

The within is a portion of that property heretofore conveyed to the grantor by deed of Mary J. Bridwell, formerly Mary J. Dobbins, recorded 6 November 1959, RMC Office for Greenville County, S. C., in Deed Book 638, at Page 190.

The following restrictions are hereby imposed on the above property, which are to run with the land until 1 October 1992, at which time said covenants shall be automatically extended for successive periods of ten (10) years unless, by vote of a majority of the then owners of this lot and adjoining lots, it is agreed to change said covenants in whole or in part:
