Elvira Guyton, her heirs and assigns forever:

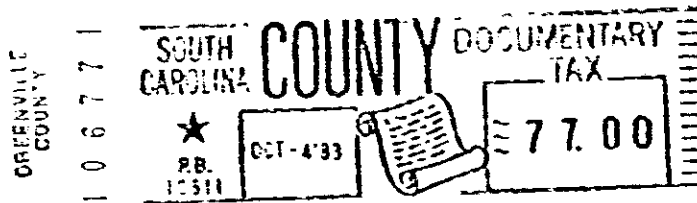
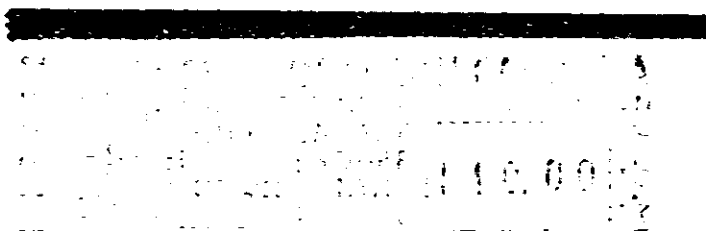
