James G. Osborn and Shirley W. Osborn, their heirs and assigns, forever:

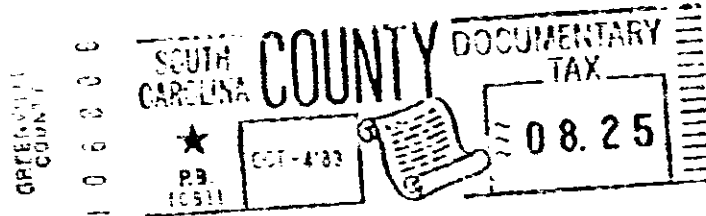
