M. G. Proffit, Inc., its successors and assigns, forever:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon lying and being on the southwesterly side of Sugarfield Court near the City of Greenville, South Carolina being known and designated as Lot 589 on Plat entitled Map I, Section 3, Sugar Creek, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 9-F, at Page 35 and having, according to said plat, the following metes and bounds, to-wit:
