in consideration of EIGHT THOUSAND FIVE HUNDRED & NO/100 (\$8,500.00) Dollars,

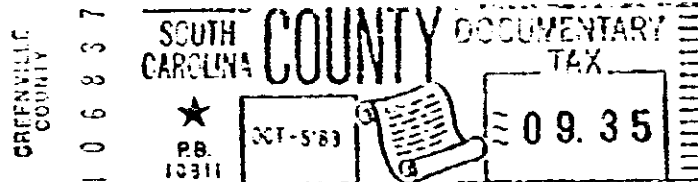
