ALL that certain piece, parcel, or lot of land situate, lying, and being in the State of South Carolina, County of Greenville, being shown as a portion of Lot No. 1 and all of Lot No. 2 on a plat prepared by Richard D. Wooten, Jr., RLS, dated September 29, 1983, recorded in the RMC Office for Greenville County in Plat Book 10-D at Page 24 and having, according to said plat, such metes and bounds as are more fully shown thereon.

This being a portion of the same property conveyed to W. W. Lindley by deed of Stella Lindley Bryson recorded on June 13, 1960, in Deed Book 652 at Page 320. W.W. Lindley died testate on January 25, 1968, leaving a wife, Pauline J. Lindley, and children, Horace Lindley, Joyce L. Behrens, Lucille L. Bull, Morris Lindley, and Mary L. Barbrey. (See Greenville County Probate Apt. 1020, File 12). According to such will, Pauline J. Lindley received a partial life estate in the above described property. Pauline J. Lindley died testate on April 11, 1982, leaving as her heirs at law children, Mary L. Barbrey, Lucille L. Bull, and Maurice Lindley (also known as Morris Lindley), and grandchildren, Derrell Lindley (Horace Lindley's son), Bruce Warren Behrens, and William Allen Behrens (Joyce L. Behrens sons).
