ALL water mains, lines, valves and appurtenances installed and located at Harrogate Hills, off Golden Strip Freeway, in Greenville County, State of South Carolina, including 240 feet, more or less, of 6" D. I. Pipe; 1,260 feet, more or less, of 2" Galv. Pipe; two (2) 6" valves; six (6) 2" valves; one (1) fire hydrant; and eight (8) valve boxes as shown on a drawing entitled "W. N. Leslie, Inc. to Commissioners of Public Works of the City of Greenville, S.C.", dated September 19, 1983, attached hereto and made a part of this conveyance.
