unto Randy J. Perry and Carolyn L. Perry, their heirs and assigns forever:

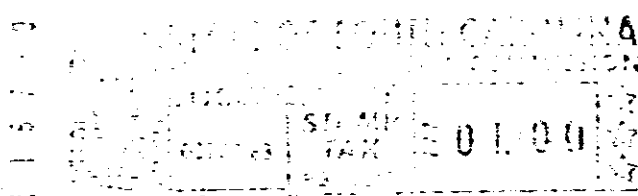
