in consideration of Twenty-Nine Thousand Nine Hundred Fifty and No/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Micheal Bentley and Vickie Bentley, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the western side of Spring Street, being shown as Lot 141, Section B, "A Subdivision for Woodside Mills, Greenville, S.C.", on plat thereof recorded in Plat Book W at Page 112 in the RMC Office for Greenville County, and being further shown on a more recent plat by Freeland & Associates, dated November 4, 1983, entitled "Property of Michael W. Bentley and Vickie S. Bentley", and having, according to said plats, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Spring Street, at the joint front corner of Lots Nos. 140 and 141, and running thence along the joint line of said lots, N. 55-08 W. 160 feet to an iron pin on the eastern side of a 12-foot alley; thence N. 34-52 E. 33 feet along East side of said alley; thence S. 72-29 E. 97.5 feet to an iron pin; thence S. 56-57 E. 67 feet to an iron pin on the western side of Spring Street; thence S. 34-52 W. 64 feet to the beginning corner.
