ALL that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, located about 27 miles up the Geer Highway about 250 yards above Bald Rock about 260 feet East of the Swimming Pool on the North side of the old Caesars Head Road beginning at the North East corner of W. F. Fortner line on said Road at Iron Pin and running a North Westerly course along W. F. Fortner Line 58 feet to Swimming Pool Street., thence skipping 50 feet for said St., thence beginning on N. Side of St. at W. F. Fortner line at pin, a north westerly course along W. F. Fortner line to Old Caesars Head to an iron pin; thence N. 87 E. 60 feet to line pin; thence a south easterly course about 200 ft. to iron pin on Swimming Pool St. on N. side; thence skipping 50 ft. for said St., thence beginning on S. side of St. at pin a south easterly course 65 ft. to Old Caesars Head Road to pin; thence a S.
