ALL that certain piece, parcel, lot or tract of land situate, lying and being in Greenville County and being a portion of 22.80 acres as shown on plat of property of Shirley and Trentham by Jones Engineering Service, dated September 20, 1979, revised September 25, 1980, and lying on the western side of Rutherford Road, and having according to said plat the following metes and bounds, to-wit:
