the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JANET P. KING, her heirs and assigns, an undivided one-ninth (1/9) interest in and to the following described real estate:

ALL that piece, parcel or lot of land being known and designated as Lot No. 6 according to a plat of Marshall Court, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "T", Page 261, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Marshall Court, corner of Lot No. 7, and running thence with the line of Lot No. 7, S. 89-52 E. 182.8 feet to an iron pin; thence S. 25-46 E. 90 feet to an iron pin; thence S. 68-15 W. 206.5 feet to an iron pin; thence N. 25-14 W. along the line of Lot No. 5, 110 feet to an iron pin; thence N. 16-12 E. 60 feet to the point of beginning. Less, however, the 2.5 feet easement which is shown on said plat.

ALSO, all that piece, parcel or lot of land adjoining the above, containing .29 acres and being shown as the Property of Lloyd Gilstrap on plat recorded in the R.M.C. Office for Greenville County in Plat Book "II", Page 182, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at corner of property above described and running thence along the line of property above described S. 68-15 W. 206.5 feet to an iron pin; thence S. 43-30 E. 95.9 feet to an iron pin on Earle Boulevard; thence with Earle Boulevard N. 46-30 E. 185.5 feet to an iron pin; thence N. 25-46 W. 19.4 feet to the point of beginning.
