UNITED STATES MARSHAL'S DEED

WHEREAS, the United States of America, for and on behalf of its agency, the Farmers Home Administration, on or about the 7th day of July, 1982, did file its complaint in the District Court of the United States for the District of South Carolina against /Jesse Rosemond, S.C. National Bank; Southern Bank & Trust, First Union National Bank of NC, Greenville, Educators Federal Credit Union & Western Carolina Regional Sewer Authority following which the matter came before the Honorable William W. Wilkins, Jr.,

United States District Judge, who, after full consideration thereof, and mature deliberation in the premises did order, adjudge and decree that the property described in the complaint, and more particularly hereinafter set forth and described, should be sold by the United States Marshal for the District of South Carolina on the terms and conditions and for the purposes set out in the Decree of Foreclosure and Sale filed on February 15, 1983 in the case, assigned civil action number 82-1702-14, all of which will more fully appear by reference to the case file in the said Court; and

WHEREAS, the United States Marshal for the District of South Carolina, after having duly advertised the said property for sale at public outcry, did openly and publicly and after the manner of auction, and in accordance with the terms and provisions of the aforesaid Decree of Foreclosure and sale, did offer the said property for sale on the 30th day of September, 1983, at which sale the plaintiff United States of America, by and through the Farmers Home Administration, was the highest bidder, the bid being the sum of Twenty Four Thousand, Seven Hundred Nineteen and 03/100 (\$24,719.03) ----- Dollars

for the property therein concerned; and

WHEREAS, no deficiency judgment having been decreed by the Court, the bidding was not required to be left open for a period of thirty (30) days, so that consequently the said sale was final, and the aforesaid high bid of the plaintiff was accepted subject to the approval of the Court, and the said plaintiff was declared to be the successful bidder; and

WHEREAS, on the 18th day of October, 1983, the Honorable William W. Wilkins, Jr., United States District Judge, did confirm the said sale and direct that the United States Marshal make title to said estate to the said purchaser; and

WHEREAS, the said purchaser has complied with the terms of its bid in accordance with the Decree above mentioned;

KNOW ALL MEN BY THESE PRESENTS, That I, the undersigned United States Marshal for the District of South Carolina, in consideration of the premises, and also in consideration of the sum of Twenty Four Thousand, Seven Hundred Nineteen and 03/100 (\$24,719.03) -- Dollars paid me by the said

United States of America, by and through its agency, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, and its assigns forever, the following described real property:

All that certain piece, parcel or lot of land situate, lying and being on the Northeastern side of the intersection of Newcastle Place and Chesley Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 45, as shown on plat of The Village, prepared by Heaner Engineering Co., Inc., dated October 13, 1972, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at Page 52, and having, according to said plat, the following metes and bounds:
