JAMES LEARY BUILDERS, INC., its Successors and Assigns, forever:

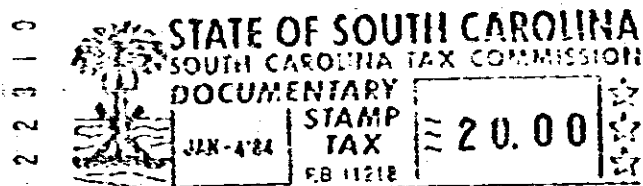
ALL that certain piece, parcel or lot of land situate, lying and being in the State of
