

Parcel 8

ALL that piece, parcel or lot of land lying and being in Greenville County, South Carolina, in the vicinity of Hobbs Road, having the following metes and bounds:

BEGINNING at an old iron pin 164.93 feet S. 86° 17' 30" W. of a bottle cap on the centerline of Hobbs Road approximately 625 feet west of the intersection of Hobbs Road and Keller Road (S-23-140); thence N. 46° 12' 30" W. 208.65 feet to an old iron pin, thence S. 12° 12' 27" W. approximately 165 feet to a point, thence N. 86° 17' 30" E. 187 feet to the point of beginning.

Hightower and Lathan Parker Hightower, and running thence, N. 09-04-58 E. 843.12 feet to a point; thence turning and running along line of Grantee's property, S. 64-16-41 W. 155 feet to a concrete monument; thence turning and running N. 65-23-38 W. 434.80 feet across State Hwy. #253 to a concrete monument corner Mackey Dill property; thence turning and again crossing State Hwy. #253, S. 04-00-49 E. 360.21 feet to a stone; thence running S. 35-52-24 W. 136.14 feet to a point in the centerline of State Hwy. #253; thence with the centerline of said highway, S. 2-45-08 E. 123.38 feet to a point in the centerline of said highway; thence continuing with said centerline, S. 12-07-08 E. 188.58 feet to a point in the centerline of said highway; thence continuing, S. 17-57-08 E. 18.44 feet to a point in said centerline; thence turning and running N. 75-21-22 E. 370.29 feet to an iron pin, corner of property of Lathan Parker Hightower; thence turning and running S. 10-50-38 E. 249.60 feet to an iron pin, the point of BEGINNING.
