ALL that certain piece, parcel or lot of land in the Town of Simpsonville, County of Greenville, State of South Carolina, situate, lying and being on the northern side of Tebblewood Drive and being known and designated as Lot No. 479, Section V, Sheet 1, of Westwood Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-X at page 62, and having, according to survey of property of Ottis L. Koontz, prepared by J. L. Montgomery II, dated January 3, 1979, the following metes and bounds, to-wit:
