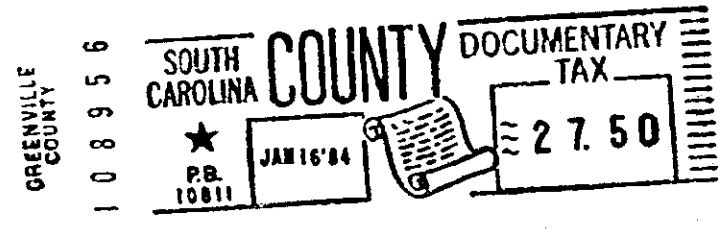
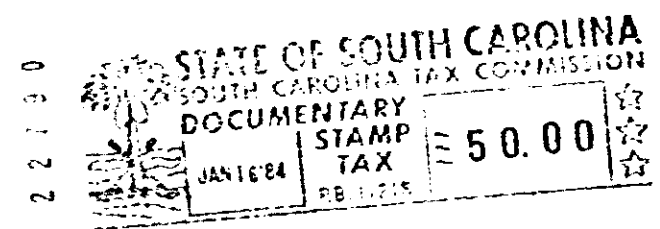
KNOW ALL MEN BY THESE PRESENTS, that **COLLEGE PROPERTIES, INC.**
