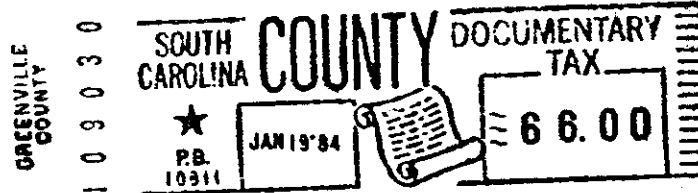
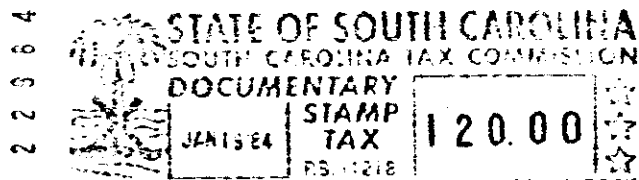
Richard W. Dean, his heirs and assigns, forever:
