- (1) The name of the corporation is MULTI-CINEMA, LTD.

 (a) To engage in the general entertainment motion picture, talking picture, drive-in and vaudeville theater business, including buying and selling, renting and handling in any manner whatever of any and all items or kinds of equipment, service and supplies that are in any degree or manner connected with or related to the operation of any kind of entertainment, show or theater; to own, lease and manage establishments or enterprises for the purpose of offering and furnishing to the public for compensation or otherwise, motion picture, talking picture or other form of entertainment, or any item or kind of equipment, service or supplies that are in any degree or manner connected with show or theater; to conduct all or any such business or enterprises upon whatever terms or whatever rates the company wishes with the right and power to act either as an agent or as a principal with the authority to buy and sell anything whatever and with the privilege of conducting business in Charlotte, North Carolina, or any other city or cities whatever.

(5) The nature of business which the corporation proposes to do in the state of South Carolina is:  
 To engage in the general entertainment motion picture, talking picture, drive-in and vaudeville theater business offering and furnishing same to the public for compensation or otherwise and to conduct the entertainment business as described in Items 4(a), (b), (c) and (d) in accordance with the laws of the State of South Carolina.
