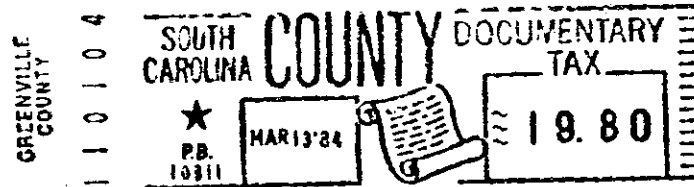
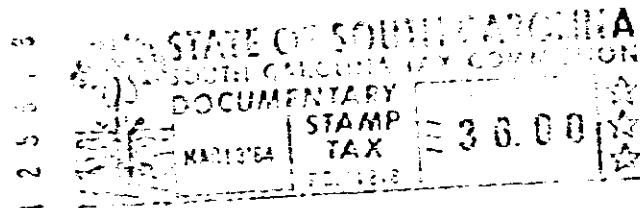

KNOW ALL MEN BY THESE PRESENTS, That we, J. Hoyt King, Emma S. Mahaffey, Ruby K. Manly Cox, Furman E. King, Robert L. King, Eunice K. Cagle Epps, Truman L. King, Grace K. Mahaffey, Dorothy K. Watt, Fred T. King, Danny Troy Epps,

in the state aforesaid, in consideration of the sum of Eighteen Thousand and No/100 (18,000.00) Dollars

to us in hand paid at and before the sealing of these presents

by Michael E. King

(The receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by

these presents do grant, bargain, sell and release unto the said Michael E. King, his heirs and assigns forever the below described real estate, to wit:

ALL that certain piece, parcel or tract of land in Greenville County, South Carolina, Dunklin Township, containing 20.29 acres, more or less, as is shown on a plat by F. E. Ragsdale, S.C.R.L.S. NO. 2303, dated January 11, 1984, and of Record in the RMC Office for Greenville County, South Carolina, in Plat Book 10-1 at Page 40, being shown and designated as Tract No. One (1) upon said plat, and having the metes and bounds and courses and distances as upon said plat appear. This Tract is bounded on the North by Epps Road, and lands of Mike L. Hall, T. H. Heatherly, Esterline E. Bagwell and H. A. Moon; bounded on the West by Holliday Bridge Road; bounded on the South by lands of Turman L. King; and on the East by lands of Louie Jordan.

THIS is a portion of that same Tract of land conveyed unto E. G. King by deed of E.
