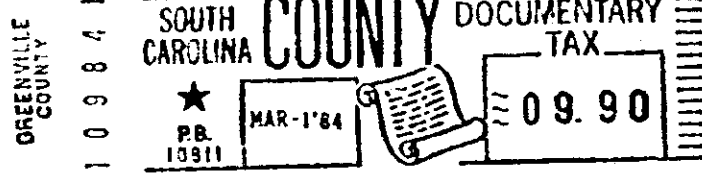
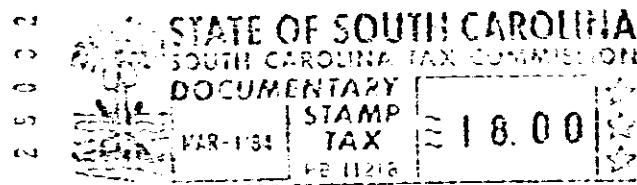
FOUNTAIN INN PRESBYTERIAN CHURCH, a South Carolina Corporation, its successors and assigns:
