KNOW ALL MEN BY THESE PRESENT THAT I, CLYDE E. CUMMINGS, OF THE STATE AND COUNTY AFORESAID, DO HEREBY NOMINATE, CONSTITUTE AND APPOINT LORENE M. CUMMINGS TO BE MY ATTORNEY IN FACT FOR ME AND IN MY NAME, PLACE AND STEAD, TO DEMAND, SUE FOR AND RECEIVE ALL PROPERTY, REAL, OR PERSONAL, TO WHICH I MAY BE ENTITLED: TO ADJUST, SETTLE, COMPROMISE OR SUBMIT TO ARBITRATION ANY MATTERS THAT MAY CONCERN ME; TO EXECUTE RECEIPTS AND DISCHARGES IN MY BEHALF; TO DEPOSIT MONIES AND CHECKS TO, AND TO DRAW CHECKS IN MY NAME AGAINST MY BANK ACCOUNTS; TO ADD TO OR WITHDRAW MONEY FROM MY SAVINGS ACCOUNTS WHEREVER SITUATE; AND TO CREATE AND CLOSE OUT SAVINGS ACCOUNTS; TO HAVE THE RIGHT OF ACCESS TO AND THE RIGHT TO PLACE ARTICLES AND PAPERS IN AND REMOVE ARTICLES AND PAPERS FROM ANY BANK DEPOSIT BOX OF MINE; TO MANAGE, SELL, CONVEY OR LEASE REAL OR PERSONAL PROPERTY: TO BUY, SELL, ENDORSE, TRANSFER, AND DELIVER STOCKS, BONDS AND OTHER SECURITIES; TO BORROW MONEY AND AS SECURITY FOR THE REPAYMENT TO SUBSCRIBED FOR, BUY, AND VOTE STOCK OR OTHER SECURITIES IN CORPORATIONS.

GRANTING AND GIVING UNTO SAID ATTORNEY IN FACT FULL AUTHORITY AND POWER TO DO AND PERFORM ALL THINGS, TRANSACT ALL BUSINESS, MAKE, EXECUTE AND PUBLISH ALL CONTRACTS, ORDERS, DEEDS, WRITINGS, ASSURANCES AND INSTRUMENTS WHICH MAY BE REQUISITE OR PROPER TO EFFECTUATE ANY MATTER OR THING PERTAINING OR BELONGING TO ME, AND GENERALLY TO ACT FOR ME IN ALL MATTERS AFFECTING MY BUSINESS OR PROPERTY WITH THE SAME FORCE AND EFFECT, AND TO ALL INTENTS AND PURPOSES AS THOUGH I WERE PERSONALLY PRESENT AND ACTING FOR MYSELF, HEREBY RATIFYING AND CONFIRMING WHATSOEVER MY ATTORNEY SHALL DO BY AUTHORITY HEREOF.
