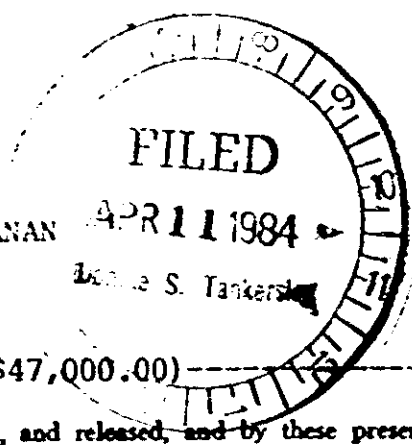

in consideration of Forty-Seven Thousand and No/100 (\$47,000.00) Dollars,

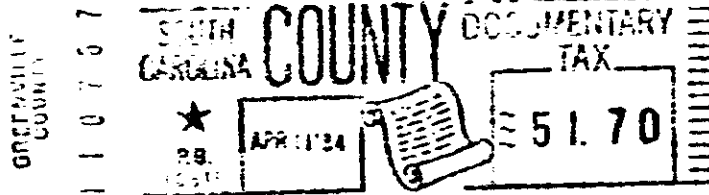
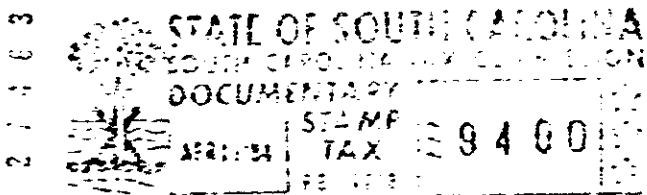
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto CHARLES I. REID and LINDA F. REID, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land located in the County of Greenville, State of South Carolina, being shown and designated as Lot N 181 Garden Trail, according to a plat entitled "Chanticleer, Section V" made by Webb Surveying & Mapping Company, dated July 1970, and recorded the RMC Office for Greenville County in Plat Book 4-F, Page 41, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Garden trail at the joint front corner of Lots 181 and 182 and running thence along the line of Lot 182, N. 56-46 W. 161.5 feet to an iron pin; thence S. 53-31 W. 15 feet to an iron pin; thence S. 10-16 W. 160 feet to an iron pin; thence S. 80-44 E. 173 feet to an iron pin; thence along the right-of-way line of Garden Trail, N. 13-52 W. 55 feet to an iron pin; thence continuing along the right-of-way line of Garden Trail N. 18-51 E. 55.6 feet to an iron pin, the point of beginning. -14-156-WG 1.3-1-182
