ALL that certain piece, parcel or lot of land situate lying and being in the State of South Carolina, County of Greenville on the south side of Maywood Drive being known and designated as a .19 tract of land as shown by plat made by Freeland and Associates dated December 13, 1983 entitled "Survey for Ronald Strange, Sr." recorded in the RMC Office for Greenville County, S.C. in Plat Book 10-N at Page 1, and having according to said plat the following metes and bounds to-wit:
