ALL those certain pieces, parcels or lots of land situate, lying and being in the town of Mauldin, County of Greenville, State of South Carolina, on the northern side of West Golden Strip Drive, and being known and designated as part of Lot No. 4 according to a plat of Golden Heights Sub-division prepared by R. B.
