the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto T. OREGON LAWTON, his heirs and assigns, forever:

ALL that property that may have been conveyed to us with the exception of
all that lot of land in Greenville County, South Carolina, near Table Rock
Dam and on the waters of Mills Creek, containing 5.8 acres, more or less,
and shown on a plat of the property of T. Oregon Lawton made by J. C. Hill
and bearing date of December 14, 1955, which plat is recorded in Plat Book
"EE" at Page 183, as a lake, and being all of said property shown as the
lake on said plat, including the dam shown on said plat.
