ALL that piece, parcel or tract of land in Butler Township, Greenville County, State of South Carolina, containing 11.447 acres, situate, lying and being on the northern side of Rocky Creek Road, and being known as property of James B. Stephens, as shown on plat thereof by C. O. Riddle, RLS, dated December 2, 1983, and recorded in the R.M.C.
