All water mains, lines, valves and appurtenances installed and located at Spartan Place, in Greenville County, State of South Carolina, including 360 feet, more or less, of 6" D. I. Pipe; 440 feet, more or less, of 2" Galv. Pipe; two (2) 6" Valves; two (2) 2" Valves; and four (4) Valve Boxes as shown on a drawing entitled "Foothills Delta P, Inc. to Commissioners of Public Works of the City of Greenville, S. C.", dated April 3, 1984, attached hereto and made part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to the said lines and all rights-of-way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
