BEGINNING at a point in the center of a county road, corner of Property of J. H. Payne; thence with line of said property N. 85-30 E. 1138.5 feet to iron pin; thence S. 46-45 W. 100 feet to iron pin corner of property of Ruby Laurence; thence with line of said property S. 79-00 W. 754 feet to iron pin corner of Atkins property; thence with line of said property N. 26-45 E. 100 feet to iron pin; thence continuing with line of said property S. 79-00 W. 441 feet to point in center of said county road; thence with center of said road N. 26-45 E. 137.6 feet to beginning corner.
