the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

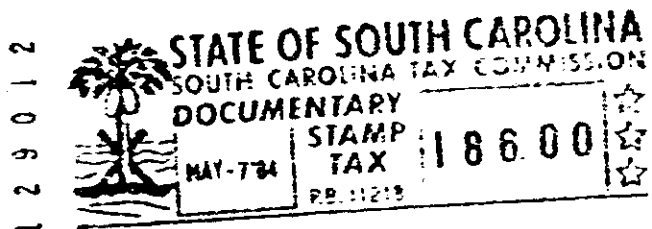
Seth A. Pope and Vieno A. Pope, Trustee for Pope Living Trust, Dated 10-31-80, its successors and assigns, forever:
