MARTIN COUNTY, STATE OF SOUTH CAROLINA, HAVE HADE, CONof GREENVILLE STITUTED AND APPOINTED, AND BY THESE PRESENTS DO MAKE, CON-MY TRUE AND LAWFUL STITUTE AND APPOINT DOROTHY MARTIN FLEMING CONDUCT ALL MY ESTATE AND ALL ATTORNEY TO ACT IN, MANAGE AND MY AFFAIRS, AND FOR THAT PURPOSE FOR HE AND IN MY NAME, PLACE AND STEAD, AND FOR HY USE AND BENEFIT, AND AS HY ACT AND DEED, TO DO AND EXECUTE, OR TO CONCUR WITH PERSONS JOINTLY INTERES-TED WITH HYSELF THEREIN IN THE DOING OR EXECUTING OF, ALL OR ANY OF THE FOLLOWING ACTS, DEEDS, AND THINGS, THAT IS TO SAY:

TO BUY, RECEIVE, LEASE, ACCEPT, OR OTHERWISE ACQUIRE.
