in consideration of One Thousand Six Hundred and no/100 (\$1,600.00)----- Dollars,

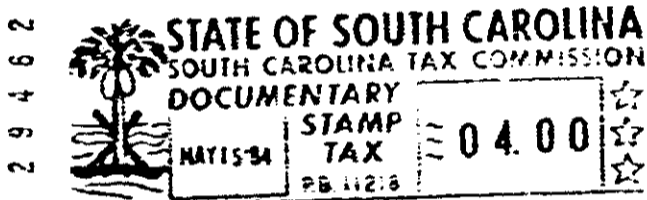

All that piece, parcel or tract of land, situate, lying and being in the State of South Carolina, County of Greenville, located near Liberty Church off of S. C. Highway 414, and according to the plat prepared for Elaine W. Ross, dated Nov. 1, 1983, as having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a dirt road that is 455.3 feet from S. C. Highway 414, and running thence S. 63-31 E. 304.43 feet (passing through an iron pin at 20 feet) to an iron pin; thence S. 42-03 W. 390.73 feet to an iron pin on the bank of the branch, thence with the branch as the line having a traverse line of S. 88-00 W. 120 feet to an iron pin; thence N. 62-40 W. 46 feet to an iron pin; thence N. 36-26 E. 419.22 feet to an iron pin; thence N. 63-31 W. 124 feet (passing through an iron pin at 104 feet) to an iron pin in the center of the dirt road, thence up the center N. 36-28 E. 20 feet to the point of beginning, and according to said plat containing 1.57 acres. 3-217-628.2-1-10.4 OUT OF 628.2-1-10-1
