AMENDMENT TO RESTRICTIONS

WHEREAS, under the building restrictions applicable to a subdivision known as TAR ACRES, recorded in the RMC Office for Greenville County, South Carolina in Deed Book 766, Page 405 on February 19, 1965, a committee was established for the purpose of examining and approving plans, specifications and location of any building proposed to be erected, placed, or altered in said subdivision, and

WHEREAS, one of the original members of said committee is now deceased, namely, Donald S. Tarbox, and the undersigned, the sole surviving member and Chairman of said committee, namely, Quentin O. Ball, now desires to resign from serving on said committee, and

WHEREAS, the building restrictions give unto the undersigned, Quentin O. Ball, as sole surviving member of said committee, the full authority and right to designate successor or successors in the event of death or resignation of any member of the committee.

NOW, THEREFORE, pursuant to the authority contained in the building restrictions applicable to TAR ACRES as recorded in Deed Book 766, Page 405 on February 19, 1965, I, Quentin O. Ball, as the sole surviving member of the architectural committee of TAR ACRES, do hereby name and appoint, in lieu of Donald S. Tarbox, now deceased, and Quentin O. Ball, who herewith resigns, being the original committee, T. A. JOHNSON, Post Office Box 734, Mauldin, South Carolina 29662 to be the member of the architectural committee of the subdivision known as TAR ACRES, with all the rights, powers and duties granted to the architectural committee in the building restrictions of the subdivision known as TAR ACRES as recorded in said RMC Office in Deed Book 766, Page 405.

This Amendment is also made applicable to Protective Covenants Applicable to Tar Acres as recorded in Deed Book 802, Page 293 on July 19, 1966 in the RMC Office for Greenville County, South Carolina.
