BEGINNING at an old iron pin on the northwestern edge of the right-of-way of Haywood Howell Road (S-273), at the joint front corner of the within tract a tract of land belonging now or formerly to First Assembly of God Corp. and running thence along joint line of said tracts N. 50-52-05 W., 787.87 feet to an old iron pin on the eastern edge of the right-of-way of Butler Springs Road, running thence with the eastern edge of Butler Springs Road N. 21-40 E., 79.14 feet to a point; N. 9-23 E., 65.6 feet to a point; N. 2-43-40 E., 160 feet to a point; N. 2-15 E., 106.25 feet to a point; N. 5-18 E., 131.6 feet to a point; N. 9-47 E., 135.95 feet to a point; N. 20-28 E., 87.5 feet to a point; N. 33-10-30 E., 127 feet to a point; N. 38-00-22 E., 193.33 feet to an old iron pin at the intersection of the rights-of-way of Butler Springs Road and a proposed street as shown on said plat; thence, with the southern edge of the right-of-way of the proposed street, N. 83-00-22 E., 35.36 feet to an iron pin; thence, along a curve, the chord of which is S. 28-58-19 E., having a radius of 386.84 feet and an arc of 310.87 feet, S. 44-19 E., 103.33 feet to an iron pin; thence along said curve, S. 28-58 E., 103.33 feet to an iron pin; S. 13-37 E., 103.27 feet to an iron pin; thence S. 5-57 E., 257.8 feet to an iron pin; thence along a curve, the chord of which is S. 29-34-39 E., having a radius of 695.47 feet and an arc of 573.59 feet, S. 9-57 E., 97.03 feet to an iron pin; thence along said curve, S. 17-57 E., 97.03 feet to an iron pin; S. 25-57 E., 97.03 feet to an iron pin; S. 33-57 E., 97.03 feet to an iron pin; S. 41-57 E., 97.03 feet to an iron pin; S. 49-34-30 E., 87.94 feet to an iron pin; thence S. 53-12-18 E., 30.15 feet to an iron pin; S. 9-07-46 E., 35.92 feet to an iron pin on the western edge of the right-of-way of Haywood Howell Road, S. 33-37 W., 42.7 feet to a point; S. 30-47 W., 102.7 feet to a point; S. 26-47 W., 102.7 feet to a point; S. 22-47 W., 102.75 feet to a point; S. 18-47 W., 102.75 feet to a point; S. 16-07 W., 46.37 feet to an old iron pin at the joint front corner of the within tract and a tract belonging now or formerly to the First Assembly of God Corp., the point and place of beginning.
