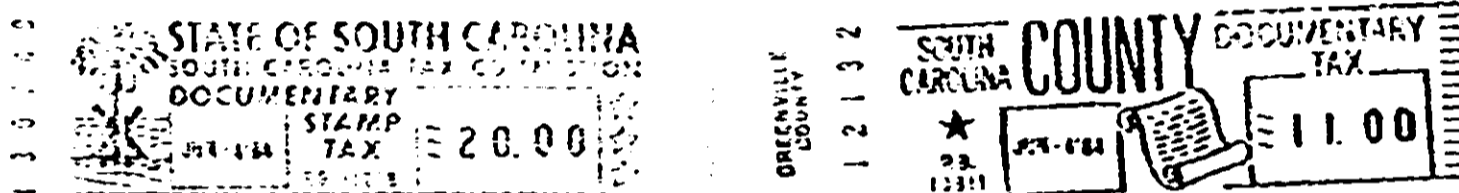
KNOW ALL MEN BY THESE PRESENTS, that CASSIE T. CRAIG

and release unto Leonard W. Craig, his heirs and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lot No. 44, on plat of Colonia Company, et al, made by Dalton and Neves, in Septmber, 1925, recorded in Plat Book G at Page 112 and according to a more recent survey prepared by C.C. Jones, Eng., September 28, 1953, is described as follows:

BEGINNING at an iron pin on the Northeastern side of Hilltop Avenue, corner of Lot 45, and running thence with the line of Lot No. 45, N 48-15 E 344 feet to a 12 foot alley; thence with said alley, S 41-45 E 50 feet; thence, S 46-03 W 194 feet to a pin; thence, S 47-33 W 150 feet to a pin on Hilltop Avenue; thence with Hilltop Avenue, N 41-45 W 60 feet to the beginning corner.
