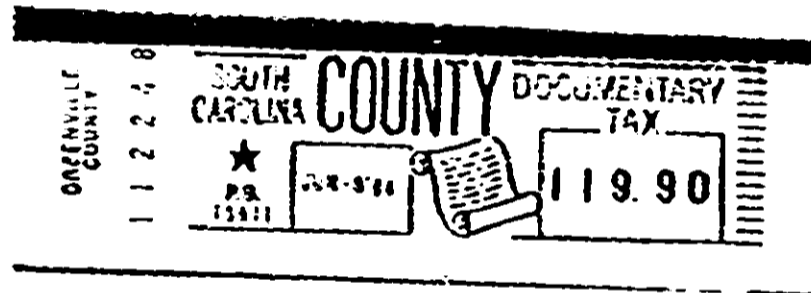
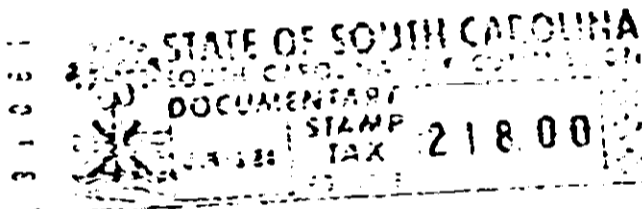
KNOW ALL MEN BY THESE PRESENTS, that American Service Corporation of South Carolina
