the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
RUBY P. SKIPPER, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land in Greenville Township, State of South Carolina, County of Greenville, on the Northside of Buist Avenue, being known and designated as Lot No. 19 of subdivision of Buist Lands, known as Oakland Heights, recorded in Plat Book F, at Page 204, and having, according to a more recent survey prepared by Freeland and Associates, dated July 26, 1983, entitled "Property of Ruby P. Skipper", the following metes and bounds, to-wit:

BEGINNING at a stake 457 feet from the corner of Robinson Street and Buist Avenue; thence with Buist Avenue in an Easterly direction 100 feet to the corner of Lots Nos. 19 and 20; thence with the joint line of said lots in a Northerly direction 170.50 feet to a stake on a 19 foot alley; thence with said alley in a westerly direction to a stake at the corner of Lots Nos. 19 and 18; thence with the joint line of said Lots in a Southerly direction 170.50 feet to the point of BEGINNING.

THIS is the same property conveyed to Alvin Watson by deed of John D. Sneak and Teresa H. Sneak, dated June 8, 1938 and recorded June 11, 1938 in the RMC Office for Greenville County in Deed Book 204 at Page 152. Alvin Watson conveyed a one-half interest to Sara Lee Watson by deed recorded August 10, 1972 in the RMC Office for Greenville County in Deed Book 951 at Page 484. Thereafter Sara Lee Watson died testate, leaving Alvin Watson as her sole beneficiary, see Greenville County Probate records at Apt. 1623, file 11.
