KNOW ALL MEN BY THESE PRESENTS: That I, WILLIAM J. GARISH, whose present address is 104 Baldwin Circle, Mauldin, South Carolina, my true and lawful attorney to act as follows: GIVING AND GRANTING unto my said attorney full power to:

sell, assign, transfer, convey, exchange, deed, quit-claim, bargain or otherwise dispose of my real estate, as follows: One (1) two-bath, three-bedroom, family dwelling, commonly known as 104 Baldwin Circle, Mauldin, South Carolina, or any custody, possession, interest, or right therein, at public or private sale, upon such terms, consideration, and conditions as my attorney shall deem advisable and to execute, acknowledge and deliver such instruments and writings of whatsoever kind and nature as may necessary, convenient or proper in the premises.

PROVIDED, however, that all business transacted hereunder for me or for my account shall be transacted in my name, and that all endorsements and instruments executed by said attorney for the purpose of carrying out the foregoing powers shall contain my name, followed by that of my said attorney and the designation "attorney-in-fact".

FURTHER, unless sooner revoked or terminated by me, this Special Power of Attorney shall become NULL and VOID from and after 7 October 1981.
