All that certain piece, parcel, or strip of land in the County of Greenville, State of South Carolina, being shown on survey entitled "Plat for Henry A. Stewart", prepared by Webb Surveying & Mapping Co., April, 1984, and having, according to said survey the following metes and bounds, to wit: BEGINNING at an old iron pin, 430 feet, more or less, northeast of Augusta Road, and running thence N. 30-00 E. 210 feet to an old iron pin; thence running S. 54-31 E. 24 feet to a spike in County Road; thence with the line at or near the center of County Road, S. 32-10 W. 209.4 feet to a spike; running thence N. 54-31 W. 16 feet to the point of BEGINNING. It is the intent of the grantors and grantee that the within strip conveys to the grantee that portion of land lying between other property of grantee and the center of the County Road above mentioned.
