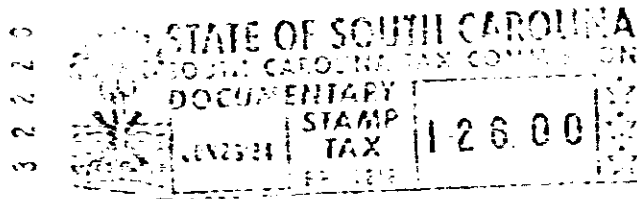
In consideration of Sixty Three Thousand (\$63,000.00) Dollars,
