and the location as determined by the County Engineer, and I (we) do hereby release and forever discharge the County of Greenville, its officers, employees, and agents from any and all liability for damages or injuries which might result to my (our) property or the plantings or improvements thereon from the performance of such work, and I (we) do hold said County harmless from any such liability.
