BEGINNING at an iron pin on the southwest corner of Whitsett Street and Carolina Avenue and running thence with Carolina Avenue S. 15-0 E., 126 feet 1 inch to an iron pin on a 10 foot alley; thence with said alley S. 76-45 W., 82 feet 8-1/2 inches to an iron pin on Westervelt's line; thence with Westervelt's line N. 15 W., 126 feet 1 inch to an iron pin on Whitsett Street; thence with Whitsett Street N. 76-45 E., 82 feet 8-1/2 inches to beginning corner.

Bettis died testate in Greenville County as reflected in the Probate Court in Apartment W1672, File 6 with the grantor being one of his children.
