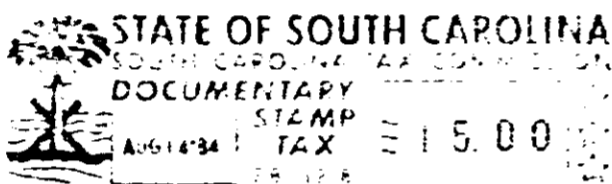
In consideration of Seven Thousand Two Hundred Fifty and no/100 (\$7,250.00) Dollars,
