the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Temple Baptist Church, its successors and assigns forever;

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, near the City of Simpsonville, and is more particularly shown on a plat entitled "Temple Baptist Church", dated June, 1984, prepared by W. R. Williams, Jr., Engineer/Surveyor, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin located at the joint corner of the subject property and property now owned by Thalia Bramlett Pollard at a point 173.48 feet from the right of way of Maple Street and running from the iron pin with the common line of subject property and property now or formerly owned by the Thalia Bramlett Pollard, S.10-30-31 E. 102.46 feet to an iron pin located on the common line of subject property and property now owned by Knabe; running thence with said line, S.69-09-35 W. 160.0 feet to an old iron pin; thence turning and running N.10-30-51 W. 102.52 feet to an old iron pin; thence turning and running N.69-13-30 E. 132.19 feet to an old iron pin; thence running N.68-58 E. 27.81 feet to an iron pin which is the point of beginning.

THIS conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights of way appearing on the property and/or of record.

THIS is the same property as that conveyed to S. T. Pollard by deed of Jessie L. Caylor (formerly Jessie L. Goodwin) and Ellen Goodwin Caldron (formerly Ellen Goodwin) recorded in the RMC Office for Greenville County in Deed Book 127 at Page 33 on November 15, 1927. S. T. Pollard died leaving Thalia Bramlett Pollard, Wilton Bramlett Pollard and Ida Frances Pollard as his sole heirs.
