This property is conveyed subject to restrictions, easements, or rights-of way, if any, of record.

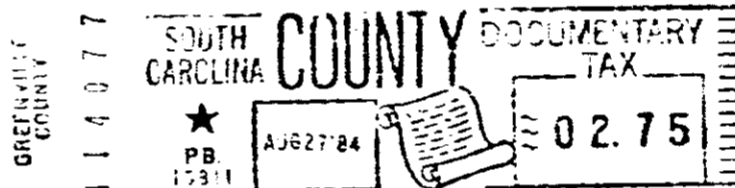
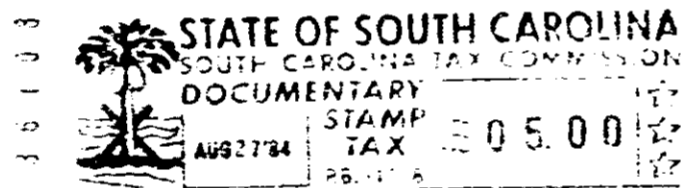
This property is a portion of the property conveyed to M. W. Fore by the following deed:
