to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, by these presents do grant, bargain, sell and release unto Samuel H. Sloan, and his heirs and assigns, forever:

All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, on the east side of the new Greenville-Laurens Highway, commencing at the joint corner of property of grantee, and running thence with line separating said properties, N. 55 E. 115 feet to a point; thence in a northerly direction, parallel with said highway 40 feet to a point; thence S. 55 W. 115 feet to a point on said highway; thence with said highway in a southerly direction 40 feet to the beginning corner.

Also, all that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, having the following metes and bounds, to-wit:

BEGINNING at a point on S. C. Highway No. 276, and running thence N. 55 E. 115 feet to a point; thence S. 16-15 E. 75 feet to a point; thence S. 55 W. 90 feet to a point on said highway; thence with said highway N. 35-30 W. 75 feet to the beginning corner.

The first parcel heretofore described was conveyed to Samuel H. Sloan for and during the term of his natural life, and then to his children by Nannie C. Sloan by deed dated March 9, 1949, recorded in Vol. 384, Page 366.

The second parcel heretofore described was conveyed to Samuel H. Sloan and Mary G. Sloan, for life, and upon the death of the survivor, to any children surviving them by deed of S. R. Sloan dated April 7, 1945, and recorded in Book H, Page 105.

The grantor herein is a child of Samuel H. Sloan and Mary G. Sloan and by this deed the grantor herein releases all of his right, title and interest in the above properties, and forever discharges any claim or right to said properties by virtue of said entailment.
