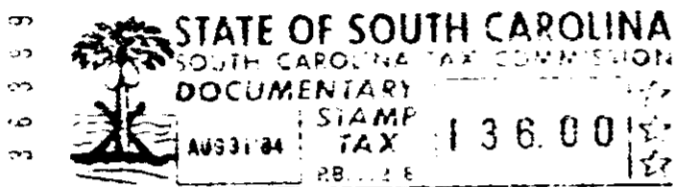
KNOW ALL MEN BY THESE PRESENTS, that THE FORTIS CORPORATION
