WHEREAS, Section 10-1 (e) of the Greenville County Code allows provision of labor and equipment to perform maintenance on dedicated drainage easements; and,

WHEREAS, said Section requires formal dedication of easements, requests of all affected property owners and that all affected property owners hold Greenville County harmless in connection with said assistance; and,

WHEREAS, said easement dedication is permanent, and does not transfer ownership of property to Greenville County; and,

WHEREAS, said agreement to hold Greenville County harmless is only for work performed as provided by this agreement; and,

WHEREAS, the undersigned agrees to the above requirements and requests the assistance of Greenville County,

NOW, THEREFORE, I (we) the undersigned do hereby dedicate a drainage easement to the general public with the width to be the widest applicable as follows:

15" - 30" Pipe	15 Feet
36" - 54" Pipe	22 Feet
Over - 54" Pipe	30 Feet

Width As Specified On A Recorded Plat	

and the location as determined by the County Engineer, ^{per the attached drawing marked "EXHIBIT A"} and I (we) do hereby release and forever discharge the County of Greenville, its officers, employees, and agents from any and all liability for damages or injuries which might result to my (our) property or the plantings or improvements thereon from the performance of such work, and I (we) do hold said County harmless from any such liability.
