All that certain piece, parcel and tract of land in Greenville County, State of South Carolina on the southern side of Edwards Circle as shown on a plat prepared by Carolina Surveying Co., which plat was recorded with the deed of May Jane Hallman and Willie A. Edwards to Melton E. Meetze as recorded in Vol. 1080 at page 20 and Plat Book 6T-Page 96. showing the following metes and bounds:

Beginning at a point in the center line of Edwards Circle, which point is 1,344 feet more or less from Roper Mountain Road, and running thence N. 86-41 E., 105.3 feet to a point in the center line of Edwards Circle; thence S. 32-08 E., 37 feet to a point; thence N. 89-40 W., 120 feet to a point; thence N. 11-09 W., 25 feet to the point of beginning, and containing .07 acres more or less.
