ALL that certain piece, parcel or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern side of Tugaloo Road, being shown as Lots 97 and 98 on a plat of Coleman Heights Subdivision, dated February 1958, prepared by Terry T. Dill, recorded in Plat Book RR at Page 115 in the RMC Office for Greenville County and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Tugaloo Road at the joint front corner of Lots 96 and 97 and running thence with Lot 96 S. 09-04 E. 253.4 feet to an iron pin at the joint rear corner of Lots 96 and 97; thence with Lot 93 S. 66-45 W. 97.5 feet to an iron pin at the joint rear corner of Lots 97 and 95; thence with Lot 95 N. 23-15 W. 150 feet to an iron pin at the joint rear corner of Lots 95 and 98; thence with Lot 98 S. 66-45 W. 175 feet to an iron pin on the eastern side of Virginia Avenue; thence with said Avenue N. 28-02 W. 159.5 feet to an iron pin; thence with the curvature of the intersection of Virginia Avenue and Tugaloo Road the ratios being 25 feet to an iron pin on the southern side of Tugaloo Road; thence with said road N. 73-39 E. 34.3 feet to an iron pin; thence still with said road N. 75-49 E. 75 feet to an iron pin; thence still with Tugaloo Road N. 81-15 E. 74.8 feet to an iron pin at the joint front corner of Lots 97 and 98; thence still with Tugaloo Road N. 88-42 E. 149.8 feet to an iron pin at the point of beginning.
